This Student Enrollment Contract is entered into by and between Pacific Academy on the one hand; and the undersigned parent(s) or guardian(s), on the other hand.

| 1. As used herein the word "I" refers to each parent or guardian signing this contract. The obligation of each person signing this contract is joint and several. In construing this contract, the singular shall imply the plural and vice versa. Pacific Academy, as used in this Contract shall refer to the school.  |

| 2. I understand that a non-refundable application fee (new students only) along with the non-refundable tuition and fees as indicated in the Tuition and Fee Contract are required for all students and must be enclosed with this contract in order for my child to be enrolled.  |

I understand and agree to abide by the policies and procedures as set forth in the school Parent/Student Handbook, which I represent that I have read and understand in its entirety; including the parent code of conduct and/or changes or revisions to school policies as posted on our website. I am aware that the school must follow strict policies regarding health and safety regulations, Department of Education, and the Department of Social Services. I understand policies and procedures are subject to change and agree that it is my responsibility to stay informed through reading any school newsletters, parent bulletin boards, and other forms of communication provided by the school. |

Payments not received by the 10th day of the month shall be subject to an additional \$10 per day late fee for each day following the 10 <sup>th</sup> day of the month. In the event payment is not honored by my bank, I agree to reimburse Pacific Academy \$50.00 for administrative costs incurred, in addition to any other late fee that might result. The school reserves the right to suspend a student any time that tuition payments become more than 30 days delinquent.  |
